



Foundation Day Raffle 2026 Terms and Conditions

1. The cost of each ticket entry into the raffle is £5. You may purchase more than one ticket. Payment to enter the raffle must be made in advance of the draw date. Any payment received after the draw date will be treated as a donation.
2. Players must be 16 or over to enter our raffle. Therefore, if a ticket is sold to, by, or bought on behalf of a person under the age of 16 they will be exempt from the raffle and will not be awarded any prize.
3. The Foundation Day Raffle is open to all UK residents aged 16 years and over, except those employees of Northampton Saints Foundation who are directly involved with the raffle.
4. Monies raised by this raffle will support the activities of Northampton Saints Foundation, registered charity number 1176345.
5. Participation in this raffle can be made by returning ticket stubs in the post with appropriate payment (cheque payable to Northampton Saints Foundation) or through purchasing direct from Foundation staff and volunteers.
6. Please keep the ticket as proof of purchase.
7. Raffle tickets will be entered into the draw only when the whole payment is received.
8. The Promoter accepts no responsibility for raffle tickets which are lost, damaged, illegible or from which the prize winner cannot be identified, or for any technical failure or event which may cause the competition to be disrupted or corrupted.
9. Any ticket entries received after the closing date may miss entry into the draw and therefore will be considered as a donation to Northampton Saints Foundation.
10. Paper tickets will be drawn randomly and anonymously.
11. Prizes will be allocated in order of the tickets being drawn from the first prize down to the last one. A full list of prizes will be advertised on our website.

16. All winners are required to co-operate with the Promoter's right to publish their win as and where deemed appropriate, and to provide proof of age when requested.
17. Refunds for payment of raffle tickets will be given only if a person under the age of 16 took part in the raffle, and won a prize that cannot be given, including after the draw took place.
