ROLE

The successful candidate will be working as a Counsellor across our Foundation programmes, the role will support the most at risk young people on our programmes, developing a bespoke pathway of emotional and practical support for each individual and collaborating with staff on the delivery of this pathway to achieve a positive outcome for each young person.

The Counsellor role will involve training and development for the operational team, including guidance on work related emotional challenges, professional growth, developing and monitoring outcomes.

The successful candidate will be patient and compassionate, with a strong level of social perception, resilient and with the ability to make young people and their support network to feel safe, secure enabling them to find their positive outcome.

KEY RESPONSIBILITIES

- Design schedules of services provided through the organisation or programme and use this to supply referrals to other professionals and community service providers, as necessary.
- Maintain relevant statistics and records and provide them to the Designated Safeguarding Lead which will be reported in monthly Trustee meetings.
- Give support to parents in their parenting obligations either as a group or individual setting using family-centred and strength-based approach.
- Organise and execute educational session in group discussion with young people on subjects relating to student challenges e.g. bereavement and loss, anger management, drug alcohol and solvent misuse.
- To identify issues, respond to referrals and conduct assessments of student needs.
- Manage and deliver 6-week interventions to a case load of young people.

- To structure action plans which ensure service delivery and statutory requirements are met.
- To develop professional relationships with colleagues, internal and external service users, and
 external agencies and to support the initiation of new partnerships to ensure that the service is
 developing and delivered effectively.
- To ensure full compliance with safeguarding protocols and process within an education setting.
- To contribute to the overall ethos, work and aims of the Foundation.
